BARANGAY SAN ISIDRO, TAYTAY, RIZAL, WITH THE PHILIPPINE ECONOMIC ZONE AUTHORITY (PEZA) FOR THE REGISTRATION OF AN INFORMATION TECHNOLOGY (IT) PARK TO BE KNOWN AS "CYBERPARK SIERRA"
