A RESOLUTION REQUESTING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO GIVE ANY KIND OF SUPPORT TO ALL IDENTIFIED STUDENTS AT RISK OF DROPPING OUT IN ALL PUBLIC ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, every local government unit has its own initiative in giving support to all students to uphold their needs in their studies and encourage them to fulfill the dreams as well as to finish their education;

WHEREAS, it is mandated in our Philippine Constitution to promote and protect the rights of every citizen to have a quality education, provide excellent services and express support to education in all levels;



WHEREAS, this kind of support shall be granted to all Identified Students at Risk of Dropping Out in every Public Elementary, Junior and Senior High Schools in the Municipality of Taytay, Rizal who cannot sustain their need most specially during their online/modular class;

WHEREAS, all Public School Principals and regular Parents Teachers Association whether in elementary or high school in the Municipality of Taytay, Rizal shall be the one who will identify the students at risk of dropping out and submit the same in the Office of the Mayor;

WHEREAS, the Municipal Government of Taytay, Rizal is encouraging each Sangguniang Kabataan in every Barangay to continuously support all programs and projects that would be able to save those identified students who are at risk of dropping out in every public elementary, junior and senior high schools within the Municipality;

WHEREAS, the assistance to be given to the Identified Students at Risk of Dropping Out shall be upon the discretion of the Local Chief Executive, Hon. George Ricardo R. Gacula II;

WHEREAS, the Sangguniang Bayan requests the Local Chief Executive to create a council thru executive order for this support/assistance program to students;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE LOCAL CHIEF EXECUTIVE HON.
