WHEREAS, the current situation of the two schools contribute to the enmity in different aspects inside and outside of the neighboring communities and bring about confusion among residents, students, employees and the government;



NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby PROMPTS THE DEPARTMENT OF EDUCATION RIZAL THRU DR. CHERRYLOU D. REPIA, CESO V, SCHOOLS DIVISION SUPERINTENDENT TO PROVIDE THE LOCAL GOVERNMENT OF THE MUNICIPALITY OF TAYTAY THE STANDPOINT AND LEGAL BASIS OF DEPED RIZAL ON THE STATUS OF THE JURISDICTION OF EXODUS ELEMENTARY SCHOOL AND ARINDA ELEMENTARY SCHOOL BOTH LOCATED WITHIN THE MUNICIPALITY OF TAYTAY, RIZAL.
