WHEREAS, Ordinance No. 14 series of 2002 requires all commercial and Industrial establishment within the Municipality of Taytay, Rizal to put up complete address on their billboards, signages and streamer for proper reference;

WHEREAS, the inclusion of address under the name of the Subdivision' Marker/Signages will be beneficial to the motorists and fellow Taytayeños;

WHEREAS, improper markers/signages can cause confusion and misunderstanding to motorist and residents within the area with regards to boundary dispute;
