**RESOLUTION NO. 325 series of 2021**

**APPROVING AND RATIFYING THE MDC – EXECUTIVE COMMITTEE  
RESOLUTION NO. 2021 – 002 ENTITLED: “A RESOLUTION AMENDING  
(ADDENDUM) THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2021 TO  
ADD THERETO THE VARIOUS PRIORITY PROJECTS / PROGRAMS FOR  
THE MUNICIPALITY OF TAYTAY, RIZAL AMOUNTING TO ONE  
HUNDRED EIGHTY-ONE MILLION SEVEN HUNDRED THIRTY-THREE  
THOUSAND SEVEN HUNDRED FOURTEEN PESOS AND TWENTY-ONE  
CENTAVOS (P 181,733,714.21)”**

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, last November 17, 2020, the Sangguniang Bayan had adopted and ratified the Annual Investment Program (AIP) for CY 2021 of the Municipality of Taytay, Province of Rizal through SB Resolution No. 241 series of 2020;



WHEREAS, last February 2, 2021, the Sangguniang Bayan had adopted and ratified the Addendum to the Annual Investment Program (AIP) for CY 2021 to add various priority projects / programs of the Municipality of Taytay, Rizal through SB Resolution No. 271 series of 2021;

WHEREAS, there is a need to amend the Annual Investment Program (AIP) CY 2021 to include the following priority projects / programs amounting to One Hundred Eighty-One Million Seven Hundred Thirty-Three Thousand Seven Hundred Fourteen Pesos and Twenty-One Centavos (P 181,733,714.21), to wit:
