WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, submitted to the Honorable August Body is MDC – Executive Committee Resolution No. 2021 – 004 entitled: “ A Resolution Appropriating Funds from the 20% Development Fund FY 2020-Surplus to various Projects / Programs for the 20% Development Fund for the Municipality”, for approval and ratification;

WHEREAS, the amount of Eleven Million Thirty-Two Thousand Nine Hundred Thirty-Two Pesos and Ninety-Four Centavos (P 11,032,932.94) from the 20% Development Fund FY 2020-Surplus is available for reversion;
