RESOLUTION NO. 329 series of 2021

A RESOLUTION RESPECTFULLY REQUESTING THE PHILIPPINE STATISTICS AUTHORITY – RIZAL THRU MS. YRA B. SIBUG, CHIEF STATISTICAL SPECIALIST TO CONSIDER SM TAYTAY AS A POSSIBLE VENUE FOR THE REGISTRATION PROCESS OF THE NATIONAL ID OF TAYTAYEÑOS

WHEREAS, Republic Act No. 11055, otherwise known as the Philippine Identification System Act, aims to establish a single national identification system for all citizens and resident aliens of the Republic of the Philippines and shall be a means of simplifying public and private transactions, and shall be a social and economic platform that promotes seamless social service delivery and strengthening of financial inclusion for both public and private services;

WHEREAS, many residents of Taytay have either been part of the PSA's house-to-house Step 1 Registration or the Online Registration for the past several months and are awaiting the venue for the Step 2 Registration that involves validating the demographic information and capturing a registrant's biometric data such as their iris scans, fingerprint scans, and front-facing photograph at designated local registration centers;

WHEREAS, many of our constituents have been inquiring on where they can proceed for their Step 2 Registration in Taytay, however, to date, all Registration Centers in Rizal are outside this Municipality, they are specifically in the City of Antipolo, Municipalities of Angono, Cardona, Jala-Jala and Tanay;


WHEREAS, having our own Registration Center located in a very strategic, convenient and conducive venue in our Municipality would be very much beneficial not only to the Hundreds of Thousands of Taytayenos but to the residents of our neighboring towns as well;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RESPECTFULLY REQUESTS THE PHILIPPINE STATISTICS AUTHORITY – RIZAL THRU MS. YRA B. SIBUG, CHIEF STATISTICAL SPECIALIST TO CONSIDER SM TAYTAY AS A POSSIBLE VENUE FOR THE REGISTRATION PROCESS OF THE NATIONAL ID OF TAYTAYENOS.

RESOLVED FURTHER, that copies of this Resolution be forwarded to the Philippine Statistics Authority – Rizal Office and to all concerned for their consideration and perusal.
