**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON.
GEORGE RICARDO R. GACULA II, TO ACCEPT THE DONATION OF A
PARCEL OF LAND LOCATED AT DE LEON COMPOUND, BARANGAY SAN
JUAN, TAYTAY, RIZAL UNDER THE DEED OF DONATION EXECUTED BY
THE HEIRS OF DOMINGO DE LEON THRU THEIR ATTORNEY-IN-FACT,
MS. CECILIA L. PARAS, IN FAVOR OF MUNICIPAL GOVERNMENT OF
TAYTAY, RIZAL**

WHEREAS, a parcel of land located at De Leon Compound, Barangay San Juan, this municipality is owned and registered under the name of Mr. Domingo De Leon;

WHEREAS, the heirs of the deceased owner, thru their Attorney-in-Fact, have executed a Deed of Donation involving the said property which is particularly covered by Tax Declaration No. 18-TY-004-25656 and with an area of 1,723 square meters;

WHEREAS, the donation of the said lot to the municipality would propel further the development of the community as the parcel of land being donated will be used for the road right of way by the resident thereat;

WHEREAS, it is worthy of note that the SMDEL Homeowners Association, Barangay San Juan, this municipality, has since been requesting for the development of their road right of way which surely would be beneficial to the inhabitants therein and its immediate vicinity;



RESOLVED FURTHER, that upon acceptance, the Deed of Donation is subject for Ratification by the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
