RESOLUTION NO. 346 series of 2021

A RESOLUTION ADOPTING THE SANGGUNIANG PANLALAWIGAN NG RIZAL ORDINANCE NO. 13 SERIES OF 2019, OTHERWISE KNOWN AS "THE PLASTIC REGULATION ORDINANCE" TO IMPLEMENT AND ENFORCE THE SOLID WASTE MANAGEMENT PRACTICES IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, Section 2 of Republic Act 9003, also known as "Ecological Solid Waste Management Act of 2000" states that it is the policy of the State to adopt systematic, comprehensive and ecological solid waste management;

WHEREAS, pursuant to Republic Act 7160 otherwise known as The Local Government Code of 1991, it is hereby declared the policy of the Municipality of Taytay to protect and safeguard the environment for the health and welfare, safety and well-being of its people. Toward this end, the Municipality Government shall establish "sustainable mechanisms to maintain

ecologically sound and healthy environment, ecotourism promotion strategy thus, enhanced local investment";

WHEREAS, it is the policy of the Rizal Provincial Government to be firmly committed to the implementation of the stated principles, policies and provisions of the Constitution, RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, there is an existing Ordinance No. 15 series of 2012, regulating the use of plastic bags, expanded polystyrene or Styrofoam and plastic receptacles, as packaging material and container in business establishments in the Municipality of Taytay, Rizal known as the "Plastic Use Regulation of 2012 of the Municipality of Taytay, Rizal", which was already superseded by Section 13 of the SP Ordinance No. 13 series of 2019;

WHEREAS, the accumulation of waste from industrial, commercial and residential sources has become one of the nation's leading environmental concerns;

WHEREAS, every Taytayeños can do more to reduce the generation of solid waste and to repair environmental degrade resulting from solid waste accumulation in the municipality and at source;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS THE SANGGUNIANG PANLALAWIGAN NG RIZAL ORDINANCE NO. 13 SERIES OF 2019, OTHERWISE KNOWN AS "THE PLASTIC REGULATION ORDINANCE" TO IMPLEMENT AND ENFORCE THE SOLID WASTE MANAGEMENT PRACTICES IN THE MUNICIPALITY OF TAYTAY, RIZAL.

RESOLVED FURTHER, that the Municipal Environment & Natural Resources Office (MENRO) shall be the implementing office of the SP Ordinance.

RESOLVED FURTHERMORE, that a copy of this resolution be furnished to all concerned for their information and appropriate action.
