**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON.
GEORGE RICARDO R. GACULA II, REPRESENTING THE MUNICIPALITY
OF TAYTAY, RIZAL TO ENTER INTO A USUFRUCT AGREEMENT WITH
THE DEPARTMENT OF EDUCATION - RIZAL REPRESENTED BY MS.
CHERRYLOU D. REPIA, CESO V, SCHOOLS DIVISION
SUPERINTENDENT, FOR THE TAYTAY SENIOR HIGH SCHOOL**

WHEREAS, the Local Government of Taytay, Rizal acquired a property located at Binhing Pag-asa St., Barangay Dolores, Taytay, Rizal and offered the same to be used as the site for Taytay Senior High School;

WHEREAS, the said property with a land area of 3,800 sq.m. covered by Tax Declaration No. 18-TY-002-14266, will be exclusively used for the improvement of the Taytay Senior High School Building and shall be built in accordance with the Municipal Site and Development Plan;

WHEREAS, the said property will be solely used by Usufructuary for educational purposes only and no charges or fees shall be collected by the Municipal Government of Taytay, Rizal within the period stated in the Deed of Usufruct;

WHEREAS, any violations of the terms and conditions in the Deed of Usufruct shall automatically revoke the agreement;

WHEREAS, the Deed of Usufruct signed by the Mayor and Schools Division Superintendent is part of the DepEd - Rizal requirement for establishing the Taytay Senior High School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II, REPRESENTING THE MUNICIPALITY OF TAYTAY, RIZAL TO ENTER INTO A USUFRUCT AGREEMENT WITH THE DEPARTMENT OF EDUCATION - RIZAL REPRESENTED BY MS. CHERRYLOU D. REPIA, CESO V, SCHOOLS DIVISION SUPERINTENDENT, FOR THE TAYTAY SENIOR HIGH SCHOOL.


RESOLVED FURTHER, that this Resolution will supersede the previously adopted Resolution No. 123, series of 2019.
