A RESOLUTION APPROVING AND RATIFYING THE ANNUAL INVESTMENT PROGRAM (AIP) FY 2022 OF THE MUNICIPALITY OF TAYTAY, RIZAL AMOUNTING TO FOUR BILLION ONE HUNDRED NINE MILLION FOUR HUNDRED THIRTY-EIGHT THOUSAND ONE HUNDRED SIXTY-SIX PESOS AND EIGHTY-SIX CENTAVOS (P 4,109,438,166.86), THEREBY ADOPTING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021 - 001

WHEREAS, submitted and presented before this Honorable August Body for review and consideration is Municipal Development Council (MDC) Resolution No. 2021 – 001 recommending adoption of the Annual Investment Program (AIP) FY 2022 amounting to Four Billion One Hundred Nine Million Four Hundred Thirty-Eight Thousand One Hundred Sixty-Six Pesos and Eighty-Six Centavos (P 4,109,438,166.86);

WHEREAS, programs, projects and activities incorporated in the Annual Investment Program (AIP) FY 2022 were categorized into General Public Services, Social Services, Economic Services and Other Services;

WHEREAS, programs, projects and activities incorporated in the Annual Investment Program (AIP) FY 2022 shall be funded by the General Fund, 20% Development Fund and funds from other possible sources or agencies;

WHEREAS, programs, projects and activities incorporated in the Annual Investment Program (AIP) FY 2022 are supportive of the development goals and thrusts of this Municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFIES THE ANNUAL INVESTMENT PROGRAM (AIP) FY 2022 OF THE MUNICIPALITY OF TAYTAY, RIZAL AMOUNTING TO FOUR BILLION ONE HUNDRED NINE MILLION FOUR HUNDRED THIRTY-EIGHT THOUSAND ONE HUNDRED SIXTY-SIX PESOS AND EIGHTY-SIX CENTAVOS (P 4,109,438,166.86), THEREBY ADOPTING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021 – 001.
