## **RESOLUTION NO. 375 series of 2021**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II, TO ACCEPT THE TURNOVER OF ORTIGAS GREENHEIGHT HOMEOWNERS ASSOCIATION (OGHA) ROADS AND OPEN SPACES TO THE TAYTAY MUNICIPAL GOVERNMENT

WHEREAS, in accordance to Presidential Decree No. 1216 there is a need to provide and maintain a healthy and suitable environment for citizens to live, by providing open spaces, alleys, sidewalks and road lots as part of the amenities of the subdivision;

WHEREAS, submitted to the Sangguniang Bayan are the Ortigas Greenheights Homeowners Association (OGHA) Board Resolution No. 2021 – 04 and the proposed Memorandum of Agreement (MOA) between the OGHA and the Municipality of Taytay, Province of Rizal, covering the specified subdivision turnover of Road Lots and Open Spaces to the municipality;

GEORGE RICARDO R. GACULA II, TO ACCEPT THE TURNOVER OF ORTIGAS GREENHEIGHT HOMEOWNERS ASSOCIATION (OGHA) ROADS AND OPEN SPACES TO THE TAYTAY MUNICIPAL GOVERNMENT.

RESOLVED FURTHER, that the signed Memorandum of Agreement for the Turnover of OGHA road lots and open spaces is subject for Ratification by the Sangguniang Bayan before its full implementation.
