AUTHORIZING THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II, TO ACCEPT THE DEED OF DONATION OF THE MARCELO FAMILY FOR THE ROAD LOTS AND OPEN SPACES OF A PROPERTY LOCATED AT FLOODWAY B, SITIO LUMANG ILOG, BRGY. SAN JUAN, TAYTAY, RIZAL, AS INDICATED IN THE SUBMITTED SUBDIVISION PLAN, TO THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL

WHEREAS, in accordance to Presidential Decree No. 1216 there is a need to provide and maintain a healthy and suitable environment for citizens to live, by providing open spaces, alleys, sidewalks and road lots as part of the amenities of the subdivision;

WHEREAS, the Homeowners Association of a property located at Floodway B, Sitio Lumang Ilog, Brgy. San Juan, Taytay, Rizal acquired said property directly from the Marcelo Family through a Community-Based Project;





WHEREAS, as a community-acquired project, the Marcelo Family wished to donate the road lots and open spaces of a property covered by Original Certificate of Title (OCT) No. 1774 containing an area of 7,299 square meters to the Municipal Government of Taytay, Rizal;

WHEREAS, the donation of road lots and open spaces will enhance further improvements beneficial to the community;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, HON.
