RATIFYING THE MEMORANDUM OF AGREEMENT WITH THE RURAL BANK OF CARDONA, LOCATED IN TAYTAY, RIZAL AS FINANCIAL PROVIDER FOR LIVELIHOOD LOAN FACILITY TO THE QUALIFIED MICRO, SMALL, MEDIUM ENTERPRISES AND BALIK PANGKABUHAYAN SA PANAHON NG PANDEMYA PROGRAM IN THE MUNICIPALITY OF TAYTAY

WHEREAS, the 11th Sangguniang Bayan had passed Resolution No. 295 series of 2021 entitled: "Authorizing the Municipal Mayor Hon. George Ricardo R. Gacula II to enter into Memorandum of Agreement with the Rural Bank of Cardona, located in Taytay, Rizal as financial provider under financial assistance program for registered and recognized Micro, Small, Medium Enterprises in the Municipality of Taytay;

WHEREAS, the Rural Bank of Cardona as a financial institution will provide financial assistance for additional working capital by way of Banks Microfinance and SME finance program through accessible and affordable loan facilities;
