**A RESOLUTION APPROVING AND RATIFYING LDRRMC RESOLUTION
NO. 2021 – 05: “A RESOLUTION REALIGNING FUNDS UNDER THE
MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE
WITHIN THE 30% QUICK RESPONSE FUND (QRF) IN THE AMOUNT OF SIX
MILLION PESOS (₱ 6,000,000.00) AND WITHIN THE 70% DISASTER
MITIGATION AND PREPAREDNESS FUND IN THE AMOUNT OF TWO
MILLION PESOS (₱ 2,000,000.00) TO SUPPORT COVID-19 RESPONSE
ACTIVITIES OF THE MUNICIPALITY OF TAYTAY, RIZAL”, FOR FY 2021**

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, Republic Act No. 10121 also known as Philippine Disaster Risk Reduction and Management Act of 2010 granted Local Government Units (LGUs) greater flexibility towards disaster mitigation, preparation and recovery;

WHEREAS, the COVID-19 Pandemic has greatly affected the lives and livelihood of the entire population, and the needed services and provisions to the public must be sustained throughout the whole duration of the COVID-19 Pandemic;

WHEREAS, submitted to the Honorable August Body is LDRRMC Resolution No. 2021 – 05 “A Resolution Realigning Funds under the Municipal Disaster Risk Reduction and Management Office within the 30% Quick Response Fund (QRF) in the amount of Six Million Pesos (₱ 6,000,000.00) and within the 70% Disaster Mitigation and Preparedness Fund in the amount of Two Million Pesos (₱ 2,000,000.00) to support COVID-19 Response Activities of the Municipality of Taytay, Rizal”, for approval and ratification;

WHEREAS, the following details the utilization of Six Million Pesos (₱ 6,000,000.00) of the LDRRM Fund under 30% Quick Response Fund to support COVID-19 related activities of the Municipality of Taytay, Rizal for FY 2021, to wit:




RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.
