NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFIES THE GENDER AND DEVELOPMENT (GAD) PLAN AND BUDGET FOR FISCAL YEAR 2022 AMOUNTING TO NINETY-FIVE MILLION TWO HUNDRED SEVENTY-NINE THOUSAND NINE HUNDRED TWENTY PESOS (PHP 95,279,920.00) OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.
