**A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT

INC., FOR THE TURNOVER OF OGHA SUBDIVISION ROADS AND OPEN

WHEREAS, the Ortigas Greenheights Homeowners Association, Inc., passed OGHA Board Resolution No. 2021 – 04 entitled: "Effecting the Turnover of OGHA Roads and Open Spaces to the Taytay Municipal Government and Directing the Signing of Memorandum of Agreement for the purpose;

WHEREAS, Ortigas Greenheights Homeowners Association Inc., submitted pertinent documents relative to the said road lots and open spaces;


WHEREAS, said turnover shall commence and intensify development activities that would be beneficial to the constituents in the community;
