A RESOLUTION APPROVING AND RATIFYING MDRRMC RESOLUTION NO. 2021 – 04: "A RESOLUTION APPROVING FY 2022 MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (MDRRMP) IN THE AMOUNT OF EIGHTY-ONE MILLION NINE HUNDRED THIRTY THOUSAND EIGHT HUNDRED FIFTY-THREE PESOS AND FIFTY CENTAVOS (PHP 81,930,853.50) FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL"

WHEREAS, Republic Act (RA) No. 10121 also known as Philippine Disaster Risk Reduction and Management Act 2010 granted Local Government Units (LGUs) greater flexibility towards disaster mitigation, preparation, response, rehabilitation and recovery;

WHEREAS, Section 12 (a) of R.A. 10121 states that Local Disaster Risk Reduction and Management Office (LDRRMO) shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction; Section 12 (c) (6) The LDRRMO shall formulate and implement a comprehensive and integrated LDRMMP in accordance with the national, regional and provincial framework and policies on disaster risk reduction in close coordination with the Local Development Councils (LDCs); Section 12 (c)(7) Prepare and submit to the Local Sangguniang through the LDRRMC

and the LDC the annual LDRRMO Plan and Budget, the proposed programming of the LDRRMF, other dedicated disaster risk reduction and management resources, and other regular funding source/s and budgetary support of the LDRRMO;

WHEREAS, the COVID-19 is still a global pandemic after its outbreak and has reprioritized programs of the MDRRMO as well as the LDRRM Council;

WHEREAS, the Municipal Disaster Risk Reduction and Management Office (MDRRMO) through the Municipal Disaster Risk Reduction and Management Council (MDRRMC), submitted MDRRMC Resolution No. 2021 – 04: A Resolution approving FY 2022 Municipal Disaster Risk Reduction and Management Plan (MDRRMP) in the amount of Eighty-One Million Nine Hundred Thirty Thousand Eight Hundred Fifty-Three Pesos and Fifty Centavos (Php 81,930,853.50) for the Municipality of Taytay, Province of Rizal, for ratification;

WHEREAS, the amount appropriated for LDRRMF represents the five percent (5%) of the estimated revenue of the Municipality of which thirty percent (30%) was allotted for Quick Response Fund (QRF) and seventy percent (70%) was for Disaster Preparedness and Mitigation;

WHEREAS, the Sangguniang Bayan finds the Municipal Disaster Risk Reduction and Management Plan (MDRRMP) and Municipal Disaster Risk Reduction and Management Fund (MDRRMF) in accordance with the provisions of the Local Government Code of 1991 or R.A. 7160 and R.A. 10121;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFIES MDRRMC RESOLUTION NO. 2021 – 04: "A RESOLUTION APPROVING FY 2022 MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (MDRRMP) IN THE AMOUNT OF EIGHTY-ONE MILLION NINE HUNDRED THIRTY THOUSAND EIGHT HUNDRED FIFTY-THREE PESOS AND FIFTY CENTAVOS (PHP 81,930,853.50) FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL".
