**RESOLUTION NO. 391 series of 2021**

**A RESOLUTION EARNESTLY REQUESTING THE HON. CHRISTOPHER  
LAWRENCE "BONG" T. GO, SENATOR, REPUBLIC OF THE PHILIPPINES,  
TO CONSIDER, ASSIST AND MAKE THE NECESSARY ARRANGEMENTS  
WITH APPROPRIATE DEPARTMENTS, AGENCIES AND OFFICES OF THE  
NATIONAL GOVERNMENT, FOR THE ESTABLISHMENT OF A MALASAKIT  
CENTER IN THE MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, the Malasakit Center institutionalized through and by virtue of R.A. 11463, has been successfully operating as a one stop shop where indigent patients efficiently access financial and medical assistance from agencies such as Philhealth, Philippine Charity Sweepstakes Office, and the Department of Social Welfare and Development;

WHEREAS, to date, the services of around one hundred thirty (130) Malasakit Center that were established in different parts of the country has been directly and overwhelmingly felt by the indigent patients seeking medical and financial assistance;

WHEREAS, the right to health of the people is a constitutionally protected right as enshrined in Section 15 of Article II of the 1987 Constitution which states as follow:

“The state shall protect and promote the right to health of the people and instill health consciousness among them.”

WHEREAS, among the top priorities of the Municipal Government of Taytay, Rizal, especially during these critical times occasioned by the COVID-19 Pandemic, is to make medical care and health services more accessible to, and adequately provided, not only to our constituents but also to the residents of the nearby municipalities within the province of Rizal;


WHEREAS, the on-going construction of the Rizal Provincial General Hospital (Taytay Annex) with 245 bed capacity and now being fast-track by the Rizal Provincial Government, which we anticipate to serve more numbers of patients, would surely be complemented by the services of the Malasakit Center, should the same be established in this municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to hereby EARNESTLY REQUESTING THE HON. CHRISTOPHER LAWRENCE “BONG” T. GO, SENATOR, REPUBLIC OF THE PHILIPPINES, TO CONSIDER, ASSIST AND MAKE THE NECESSARY ARRANGEMENT WITH APPROPRIATE DEPARTMENTS, AGENCIES AND OFFICES OF THE NATIONAL GOVERNMENT, FOR THE ESTABLISHMENT OF A MALASAKIT CENTER IN THE MUNICIPALITY OF TAYTAY, RIZAL.
