RESOLUTION NO. 392 series of 2021

A RESOLUTION ADOPTING THE IATF IMPLEMENTATION OF ALERT LEVELS SYSTEM FOR COVID-19 RESPONSE IN PILOT AREAS FOR THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the President issued Proclamation No. 1218 (s. 2021) further extending the period of the State of Calamity throughout the Philippines until September 12, 2022, due to COVID-19 Pandemic;

WHEREAS, the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases adopted and published the Guidelines for the Pilot Implementation of Alert Levels System in the National Capital Region on September 13, 2021;

WHEREAS, on October 14, 2021, the IATF issued Resolution No. 143-A series of 2021, placing the Rizal Province under Modified Enhanced Community Quarantine (MECQ) until October 31, 2021;

WHEREAS, on October 18, 2021, the IATF issued Resolution No. 144-D series of 2021, placing the Rizal Province under Alert Level 3 (Pilot Implementation) from October 20 - 31, 2021;

WHEREAS, with the change in the community quarantine classification of Rizal Province from MECQ to Alert Level 3, the 11th Sangguniang Bayan deems it just and proper to adopt the IATF Guidelines on the Implementation of Alert Levels System for COVID-19 Response in Pilot Areas as of October 13, 2021, for the proper implementation of the new community quarantine classification in the Municipality of Taytay, Rizal;

WHEREAS, the Sangguniang Bayan also deems it necessary to adopt all the guidelines for Alert Level 1- 5 in consonance with the declaration of the IATF in the coverage of the area whether the province is covered by certain level of alert;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS THE IATF IMPLEMENTATION OF ALERT LEVELS SYSTEM FOR COVID-19 RESPONSE IN PILOT AREAS FOR THE MUNICIPALITY OF TAYTAY, RIZAL


RESOLVED FURTHER, that all existing Ordinances pertaining to certain Alert Level shall be observed.
