RESOLUTION NO. 395 series of 2021

A RESOLUTION REQUESTING ALL PRIVATE LANDOWNERS OF TODA TERMINALS TO HOLD ON STATUS QUO THE PAYMENT OF RENTAL FEES ON THEIR PROPERTY

WHEREAS, the President issued Proclamation No. 1218 (s. 2021) further extending the period of the State of Calamity throughout the Philippines until September 12, 2022, due to COVID-19 Pandemic;

WHEREAS, some Tricycle Operators and Drivers Association (TODA) in the Municipality of Taytay have been renting private land to be used as their TODA Terminals;

WHEREAS, the Municipality of Taytay has been declared under a more-restricted community quarantine since March of this year, limiting the number of passengers allowed to ride tricycles thus lowering the income of tricycle drivers;

WHEREAS, the Sangguniang Bayan received a letter from Taytay Municipal Tricycle Franchising and Regulatory Office (TMTFRO) regarding the situation of TODAs in the municipality as well as the intent of the private landowners to increase the rental fees on their property utilized as TODA Terminals thus, the TMTFRO recommends to extend some measures of relief or any means allowable by law to effect a freezing or status quo on said rental rates;

WHEREAS, the 11th Sangguniang Bayan finds the TODA situation and TMTFRO recommendation worthy of legislation to cope during this time of need due to Pandemic;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to hereby REQUESTS ALL PRIVATE LANDOWNERS OF TODA TERMINALS TO HOLD ON STATUS QUO THE PAYMENT OF RENTAL FEES ON THEIR PROPERTY.

RESOLVED FURTHER, that a Memorandum of Agreement (MOA) between the Land Owners and the TODAs, that is beneficial to both parties be formed and signed for this purpose.

RESOLVED FURTHERMORE, to send copies of this Resolution to all concerned for their information and consideration.
