## **RESOLUTION NO. 397 series of 2021**

**A RESOLUTION AUTHORIZING THE HON. GEORGE RICARDO R. GACULA  
II, MAYOR, TAYTAY, RIZAL, TO ENTER INTO A MEMORANDUM OF  
AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF RIZAL,  
REPRESENTED BY HON. REBECCA A. YNARES, PROVINCIAL GOVERNOR,  
REGARDING THE SECOND TRANCHE OF COVID-19 SPECIAL RISK  
ALLOWANCE FOR HEALTH WORKERS AT MUNICIPAL HEALTH OFFICE  
AND TAYTAY EMERGENCY HOSPITAL**

WHEREAS, Section 4(h) of Republic Act 11494, or the Bayanihan to Recover as One Act, authorizes the national government to grant "COVID-19 Special Risk Allowance" to all public and private health workers (HWs) directly catering to COVID-19 confirmed patients for every month that they serve during the declaration of state of national emergency;



WHEREAS, last June 1, 2021, Administrative Order No. 42 was issued to implement the continued grant of COVID-19 Special Risk Allowance to Public and Private Health Workers directly catering to or in contact with COVID-19 patients covering the period from December 20, 2020 to June 30, 2021;

WHEREAS, the DOH issued the Memorandum Circular No. 2021-0027, dated June 1, 2021, giving information and guidance on Administrative Order No. 42;

WHEREAS, the LGU has been tasked by the DOH-Center for Health Development Calabarzon to facilitate the prompt disbursement of funds to cover the benefits of the HWs in response to the COVID-19 health emergency (COVID-19 benefits);

WHEREAS, the Municipal Health Office and Taytay Emergency Hospital, is a public health facility owned by the Municipal Government of Taytay, employing the services of HWs assigned at designated COVID-19 units, who provide critical and urgent services to respond to the public health emergency during the state of national emergency, and who are eligible recipients of the COVID-19 benefits covered by the Sub-allotment advice;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to hereby AUTHORIZES THE HON. GEORGE RICARDO R. GACULA II, MAYOR, TAYTAY, RIZAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF RIZAL, REPRESENTED BY HON. REBECCA A. YNARES, PROVINCIAL GOVERNOR, REGARDING THE SECOND TRANCHE OF COVID-19 SPECIAL RISK ALLOWANCE FOR HEALTH WORKERS AT MUNICIPAL HEALTH OFFICE AND TAYTAY EMERGENCY HOSPITAL.

RESOLVED FURTHER, that health workers and other allied personnel entitled to the benefits under the continued grant of COVID-19 Special Risk Allowance shall be determined by the Head of the Municipal Health Office in accordance with the criteria set forth in Republic Act 11494 as implemented by Administrative Order No. 42 dated June 1, 2021.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
