APPROVING AND RATIFYING THE MDC RESOLUTION NO. 2021 – 002 ENTITLED: "A RESOLUTION AMENDING (ADDENDUM) THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2021 TO ADD THE VARIOUS PRIORITY PROJECTS / PROGRAMS FOR THE MUNICIPALITY OF TAYTAY, RIZAL AMOUNTING TO NINE MILLION SIX HUNDRED SEVENTY-FOUR THOUSAND NINE HUNDRED THIRTY-NINE PESOS AND THIRTY-FIVE CENTAVOS (PHP 9,674,939.35)"

WHEREAS, last February 2, 2021, the Sangguniang Bayan had adopted and ratified the Addendum to the Annual Investment Program (AIP) for CY 2021 to add various priority projects / programs of the Municipality of Taytay, Rizal through SB Resolution No. 271 series of 2021;

WHEREAS, last June 15, 2021, the Sangguniang Bayan had adopted and ratified the Addendum to the Annual Investment Program (AIP) for CY 2021 to add various priority projects / programs of the Municipality of Taytay, Rizal through SB Resolution No. 325 series of 2021;

WHEREAS, there is a need to amend the Annual Investment Program (AIP) CY 2021 to include the following priority projects / programs amounting to Nine Million Six Hundred Seventy-Four Thousand Nine Hundred Thirty-Nine Pesos and Thirty-Five Centavos (Php 9,674,939.35), to wit:
