## **RESOLUTION NO. 407 series of 2021**

**APPROVING AND RATIFYING THE MDC RESOLUTION NO. 2021 – 003  
ENTITLED: “A RESOLUTION AMENDING (ADDENDUM) THE ANNUAL  
INVESTMENT PROGRAM (AIP) CY 2022 TO ADD THE VARIOUS PRIORITY

TAYTAY, RIZAL AMOUNTING TO FOUR HUNDRED FORTY-ONE MILLION


WHEREAS, submitted to the Honorable August Body is MDC Resolution No. 2021 – 003 for approval and ratification;


RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.
