**APPROVING AND RATIFYING THE MDC RESOLUTION NO. 2021 – 005
ENTITLED: “A RESOLUTION ALLOCATING THE AMOUNT OF TWO
HUNDRED EIGHT MILLION SIX HUNDRED FIFTY-THREE THOUSAND
FOUR HUNDRED FOURTEEN PESOS (PHP 208,653,414.00) REPRESENTING
THE 20% DEVELOPMENT FUND FY 2022 TO FUND THE VARIOUS
PRIORITY PROJECTS / PROGRAMS FOR THE MUNICIPALITY”**

WHEREAS, Section 16 of the Local Government Code, states that every LGU shall appropriate in its annual budget no less than twenty percent (20%) of its Annual Internal Revenue Allotment for development projects;

WHEREAS, submitted to the Honorable August Body is MDC Resolution No. 2021 - 005 allocating the amount of Two Hundred Eight Million Six Hundred Fifty-Three Thousand Four Hundred Fourteen Pesos (Php 208,653,414.00), the amount equivalent to the 20% of Annual Internal Revenue Allotment of this Municipality, for approval and ratification;

WHEREAS, integrated in MDC Resolution No. 2021 - 005 are priority development projects and programs to be funded out of the 20% Development Fund for FY 2022;

WHEREAS, projects and programs to be funded out of the 20% Development Fund are truly responsive to the needs of the community and supportive of the Development goals and thrusts of the Municipality, to wit:


