A RESOLUTION CREATING THE PERSONNEL SELECTION BOARD OF THE MUNICIPAL GOVERNMENT OF TAYTAY

WHEREAS, Article XI, Section 1 of the 1987 Constitution enshrines the principle that public officers and employees must be accountable to the people at all times, and requires public officers and employees to serve the people with utmost responsibility, integrity, loyalty, and efficiency;

WHEREAS, Title III, Section 76 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code provides that all local government unit shall design and implement its own organizational structure and staffing pattern pursuant to the requirements of civil service laws and other applicable laws, rules and regulations;

WHEREAS, Title III, Section 80 of R.A. No. 7160 provides that the Personnel Selection Board of local government units shall be headed by the Local Chief Executive, and the members shall include a representative of the Civil Service Commission, if any, and the personnel officer of the local government unit concerned as *ex officio* members, pursuant to a resolution issued by the Sanggunian;

WHEREAS, Rule 1, Section 1 to 3 of Civil Service Commission Resolution No. 1800692, otherwise known as the 2017 Omnibus Rules on Appointments and Other Human Resource Actions (Revised 2018) reiterates the Constitutional mandate that appointments and any human resource actions shall be compliant with the principles of merit and fitness, pursuant to the requirements of civil service laws and other applicable laws, rules and regulations;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to ESTABLISH THE PERSONNEL SELECTION BOARD OF THE MUNICIPALITY OF TAYTAY, WITH THE FOLLOWING COMPOSITION:
