RESOLUTION NO. 7 series of 2022

A RESOLUTION AUTHORIZING THE HON. MAYOR ALLAN MARTINE S. DE LEON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), REPRESENTED BY ITS CHAIRMAN AND CHIEF EXECUTIVE OFFICER, FOR THE ACCEPTANCE OF THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF FOUR MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (₱ 4,750,000.00) FOR THE PURCHASE OF FIVE (5) UNITS OF DIALYSIS MACHINES

WHEREAS, a request was made through President Rodrigo Roa R. Duterte for five (5) units of dialysis machines for the Municipality of Taytay, Rizal;

WHEREAS, the said request was granted through PAGCOR,

WHEREAS, PAGCOR though its Board of Directors approved the grant of financial assistance in the amount of Four Million Seven Hundred Fifty Thousand Pesos (₱ 4,750,000.00) in favor of the Municipality of Taytay, Rizal for the procurement of five (5) units Dialysis Machines;

WHEREAS, a Memorandum of Agreement for the said purpose is needed between PAGCOR and the Municipal Government of Taytay, Rizal;


WHEREAS, under the Local Government Code, the Local Chief Executive is mandated to represent the Municipality in entering into contracts after being authorized for the said purpose,

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE HON. MAYOR ALLAN MARTINE S. DE LEON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), REPRESENTED BY ITS CHAIRMAN AND CHIEF EXECUTIVE OFFICER, FOR THE ACCEPTANCE OF THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF FOUR MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (₱ 4,750,000.00) FOR THE PURCHASE OF FIVE (5) UNITS OF DIALYSIS MACHINES.

RESOLVED FURTHER, that a copy of this Resolution be furnished with the PAGCOR and other Offices concerned.
