RESOLUTION NO. 9 series of 2022

A RESOLUTION AUTHORIZING HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) AND DEED OF DONATION WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) REPRESENTED BY ITS CLUSTER DIRECTOR, MS. CHERYL C. ORTEGA, REGARDING THE IMPLEMENTATION OF TECH4ED PROJECT AND FOR THE MUNICIPAL GOVERNMENT TO RECEIVE ANY OTHER TECH4ED EQUIPMENT PACKAGE AND RELATED PROGRAMS

WHEREAS, it is mandated that Department of Information and Communications Technology (DICT) shall bridge to enhance socio-economic condition by providing inclusive growth to the country by establishing Technology for Education, Employment, Entrepreneurs and Economic Development (Tech4Ed) Centers under Filipino Technology for economic development project;

WHEREAS, the Tech4Ed programs aim to cater to Out-of-School Youth (OSY) and adults, women, teachers, OFWs as well as their families and relatives, Solo Parents, LGBTQs, PWDs, Senior Citizens and Indigenous people and entrepreneurs as its target end users;

WHEREAS, the Local Government Unit of Taytay, Rizal (LGU) manifested its desire in continuing the operation of its Tech4Ed Center and has attested to support all activities to sustain and maintain the Center and provide, when and where feasible, services to the community;

WHEREAS, both DICT and LGU of Taytay have agreed to cooperate and jointly commit in promoting community development through the use of Information Communication Technology for effective and efficient governance in the country, particularly through this program;

WHEREAS, in line with the common goal of this program, the LGU of Taytay shall continuously provide necessary support for the success of the program;

WHEREAS, upon careful evaluation and review of the transmitted copy of the Memorandum of Agreement and Deed of Donation, the August Body found that the agreements do not, in anyway, contradict with existing law;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) AND DEED OF DONATION WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) REPRESENTED BY ITS CLUSTER DIRECTOR, MS. CHERYL C. ORTEGA, REGARDING THE IMPLEMENTATION OF TECH4ED PROJECT AND FOR THE MUNICIPAL GOVERNMENT TO RECEIVE ANY OTHER TECH4ED EQUIPMENT PACKAGE AND RELATED PROGRAMS.

RESOLVED FURTHER, that the duly signed MOA and Deed of Donation shall be ratified first by the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that a copy of this Resolution be furnished to all concerned for their information and appropriate action.
