A RESOLUTION APPROVING IN REVIEW AND DECLARING SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2022 INVOLVING THE AMOUNT OF FOURTEEN MILLION ONE HUNDRED EIGHTY-FOUR THOUSAND EIGHT HUNDRED EIGHT AND TWENTY-SIX CENTS (PHP 14,184,808.26) OF BARANGAY SAN JUAN UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1 SERIES OF 2022, OPERATIVE SUBJECT TO CONDITIONS

WHEREAS, Supplemental Budget No. 1 involving the amount of Fourteen Million One Hundred Eighty-Four Thousand Eight Hundred Eight and Twenty-Six Cents (Php 14,184,808.26) of Barangay San Juan under Sangguniang Barangay Appropriation Ordinance No. 1 series of 2022 was submitted to the Sangguniang Bayan for purposes of review;

WHEREAS, Committee on Finance, Budget and Appropriation after reviewing Supplemental Budget No. 1 series of 2022 of Barangay San Juan recommended that it be declared Operative subject to the conditions stated in its report;


WHEREAS, Supplemental Budget No. 1 series of 2022 of Barangay San Juan is in conformity with existing budgetary rules and regulations in accordance with the provisions of the local government code of 1991 and there are no impediment for the immediate approval thereof;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2022 INVOLVING THE AMOUNT OF FOURTEEN MILLION ONE HUNDRED EIGHTY-FOUR THOUSAND EIGHT HUNDRED EIGHT AND TWENTY-SIX CENTS (PHP 14,184,808.26) OF BARANGAY SAN JUAN UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1 SERIES OF 2022, OPERATIVE SUBJECT TO CONDITIONS.


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
