RESOLUTION NO. 12 series of 2022

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH TAYTAY MUNICIPAL EMPLOYEES MULTI-PURPOSE COOPERATIVE (TAMEMCO), REPRESENTED BY ITS CHAIRPERSON MS. JULIETA JUANILLO

WHEREAS, Taytay Municipal Employees Multi-Purpose Cooperative (TAMEMCO) is an employee initiated cooperative in the Municipal Government of Taytay, Rizal since the year 2000;

WHEREAS, the Municipal Government is very supportive of TAMEMCO as this cooperative greatly benefits its employees particularly in the time of need, thus allowed the use of the Municipal Canteen and a photocopy machine as sources of funds of the Cooperative;

WHEREAS, Article 62 Privileges of Cooperatives (2) of RA 9520 or The Philippine Cooperative Code of 2008 states that “Cooperatives organized among government employees, notwithstanding any law or regulation to the contrary, shall enjoy the free use of any available space in their agency, whether owned or rented by the Government”;

WHEREAS, TAMEMCO wishes thru a Memorandum of Agreement with the Municipal Government of Taytay to formally manage the Canteen of the Municipal Building which it has been managing since 2007 and the continuation of operation of a photocopy machine which it has been handling since 2013;

WHEREAS, the 12th Sangguniang Bayan deems the request worthy of legislation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH TAYTAY MUNICIPAL EMPLOYEES MULTI-PURPOSE COOPERATIVE (TAMEMCO), REPRESENTED BY ITS CHAIRPERSON MS. JULIETA JUANILLO.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement between the Municipal Government and TAMEMCO shall be ratified first by the Sangguniang Bayan before its implementation.

RESOLVED FURTHERMORE, that a copy of this Resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 13th day of July 2022, 5:05 PM at the Sangguniang Bayan Session Hall, Municipality of Taytay, Province of Rizal.
