## **RESOLUTION NO. 13 series of 2022**

A RESOLUTION EXPRESSING THE CONCURRENCE OF THE MEMBERS OF THE SANGGUNIANG BAYAN NG TAYTAY TO THE APPOINTMENT OF ATTY. SOLIMAN ALLEN V. BAUTISTA AS THE MUNICIPAL ADMINISTRATOR IN THE MUNICIPALITY OF TAYTAY

WHEREAS, Section 443(b) of Republic Act ("RA") No. 7160, otherwise known as the Local Government Code of 1991 provides that the Municipal Mayor may appoint a Municipal Administrator;

WHEREAS, Section 443(d) of RA No. 7160 provides that the heads of departments and offices appointed by the Municipal Mayor with the concurrence of the majority of all the members of the Sangguniang Bayan, subject to Civil Service laws, rules and regulations;



WHEREAS, Municipal Mayor Allan Martine S. De Leon appointed Atty. Soliman Allen V. Bautista to serve as the Municipal Administrator of the Municipality of Taytay as of 01 July 2022:

WHEREAS, the Sangguniang Bayan of Taytay concurs the appointment of Atty. Soliman Allen V. Bautista as the Municipal Administrator of the Municipality of Taytay;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, duly assembled in session, hereby EXPRESSES THE CONCURRENCE OF THE MEMBERS OF THE SANGGUNIANG BAYAN NG TAYTAY TO THE APPOINTMENT OF ATTY. SOLIMAN ALLEN V. BAUTISTA AS THE MUNICIPAL ADMINISTRATOR IN THE MUNICIPALITY OF TAYTAY.

RESOLVED FURTHER, that the appointment of Atty. Soliman Allen V. Bautista shall be subject to applicable laws, rules and regulations issued by the Civil Service Commission and other appropriate agencies.
