RESOLUTION NO. 15 series of 2022

A RESOLUTION HUMBLY REQUESTING HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO CREATE A TECHNICAL WORKING GROUP FOR FLOOD CONTROL AND MITIGATION THAT WILL PROPOSE, PLAN, DESIGN, CONSOLIDATE AND IMPLEMENT PROGRAMS, PROJECTS AND SOLUTIONS IN CONTROLLING AND REDUCING THE IMPACT OF FLOOD IN THE MUNICIPALITY OF TAYTAY, MINIMIZING OR PREVENTING DAMAGE TO LIFE AND PROPERTY

WHEREAS, Section 16 of the Local Government Code of 1991 states that, "every local government unit shall exercise the power expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance,

and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants";

WHEREAS, Section 17 (2)(viii) of the Local Government Code of 1991 states that, "The infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects and other similar projects; fish ports, artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities";

WHEREAS, Section 440 of the Local Government Code of 1991 states that, the "Role of the Municipality, consisting of a group of Barangays, serves primarily as a general-purpose government for the coordination and delivery of basic, regular and direct services and effective governance of the inhabitants within its territorial jurisdiction";

WHEREAS, Section 441 (b)(1)(xvi) states that part of the Powers, Duties and Functions of the Local Chief Executive is to "Call upon any national official or employee stationed in or assigned to the Municipality to advise them on matters affecting the Municipality and to make recommendations thereon, or to coordinate in the formulation and implementation of plan, programs and projects";

WHEREAS, this Resolution is in line with the priority programs of Honorable Mayor Allan Martine S. De Leon particularly the *Systematic Dredging and Widening* of Municipal Rivers, Creeks, and Esteros, whether Primary, Secondary, Tertiary or Tributary and all those collecting and transporting flood water from household drains up to the Outfall which is the Laguna Lake through Manggahan Floodway;

WHEREAS, the creation of Technical Working Group will help provide the Local Government Unit a comprehensive Flood Control and Mitigation Plan, adequate engineering solutions, consolidate all the projects in every Barangay within the Municipality utilizing the established elevation origin to divert the evaluated contributors of flood water from household drains traversing to the rivers, creeks and canals directing to Laguna Lake thru Manggahan Floodway;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby HUMBLY REQUESTS HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO CREATE A TECHNICAL WORKING GROUP FOR FLOOD CONTROL AND MITIGATION THAT WILL PROPOSE, PLAN, DESIGN, CONSOLIDATE AND IMPLEMENT PROGRAMS, PROJECTS AND SOLUTIONS IN CONTROLLING AND REDUCING THE IMPACT OF FLOOD IN THE MUNICIPALITY OF TAYTAY, MINIMIZING OR PREVENTING DAMAGE TO LIFE AND PROPERTY.

RESOLVED FURTHERMORE, that the Technical Working Group's scope of work includes, but is not limited to:

- 1. Updating of existing elevation of roads, drainage, rivers, creeks, and esteros with reference to the established origin.
- 2. Identify and evaluate the contributors of flood water traversing into the Municipality's rivers, creeks and esteros.
- 3. Reporting and consolidating all the projects of National, Provincial, Municipal and Barangay (proposed, on-going and completed) within the Municipality to conform with the Proposed Flood Control and Mitigation Plan.
- 4. Creation of teams and/or groups necessary for the implementation of the proposed solution within the project plan.
- 5. Continue the process of providing adequate engineering solutions that will benefit the future generations.
- 6. Update the Sangguniang Bayan regarding the accomplishment of the Technical Working Group.

RESOLVED FINALLY, that a copy of this Resolution shall be issued to all concerned Offices for their information and appropriate action.
