WHEREAS, Mr. Roderick "Jerick" Ternida is the First Filipino to win Overall World Championship Title in the World Lightweight Bodybuilding Competition that put the Philippines in the limelight of the world Bodybuilding Competition;

WHEREAS, Mr. Ternida was congratulated and commended by the Senate of the Philippines through the Resolution No. 133 s. 2008, for Winning the 2008 Musclemania Universe Middle Weight Class Champion and 2008 Musclemania Universe Over-All Champion in Miami, Florida, U.S.A. and for being the First Filipino to become a World Champion in The World Lightweight Bodybuilding Competition;

WHEREAS, Mr. Ternida was also awarded as Municipality of Taytay, Rizal 2008 Outstanding Citizen;

WHEREAS, Mr. Ternida joined His Creator on July 16, 2022;

WHEREAS, it is proper that The Municipal Government of Taytay grant him a Plaque and Cash, in the amount of Fifty Thousand Pesos (Php 50,000.00) through his wife Mrs. Janine Ternida, in recognition of his achievements and contributions;
