**RESOLUTION ADOPTING DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) MEMORANDUM CIRCULAR NO. 2022 – 083
GUIDELINES ON THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS AND SELECTION OF REPRESENTATIVES TO THE
LOCAL SPECIAL BODIES**

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations of the Local Government Code of 1991, mandates local government units to promote the establishment and operation of people's organizations, NGOs, and the private sector, to make them active partners in the pursuit of local autonomy and to directly involved them in the plans, programs, projects, or

activities of Local Government Unit, such as but not limited to, membership in local special bodies (LSBs);

WHEREAS, Article 64 of the same Implementing Rules and Regulations provides for the criteria for accreditation as well as procedures and guidelines for selection of representatives of People's Organization, Nongovernmental Organization, or the Private Sector in Local Special Bodies;

WHEREAS, the Department of Interior and Local Government has issued a Memorandum Circular No. 2022 – 083, providing a more detailed guidelines on the process for accreditation and selection of CSOs and their representatives to the Local Special Bodies (LSBs);


WHEREAS, the Local Government Unit of Taytay, Rizal recognizes the value of People's Organizations, Nongovernmental Organizations, and the Private Sector and the accreditation of Civil Society Organizations and encourages them to be involved in the growth and development of the Municipality;


RESOLVED FURTHER, that copies of this Resolution be forwarded to all concerned for their information and appropriate action.
