RESOLUTION NO. 24 series of 2022

A RESOLUTION REQUESTING THE LOCAL CHIEF EXECUTIVE, MAYOR ALLAN MARTINE S. DE LEON TO TEMPORARILY ALLOCATE THE THIRD FLOOR OF THE NEW TAYTAY PUBLIC MARKET FOR GOVERNMENT OFFICES

WHEREAS, Section 444 (B)(ix) of the Local Government Code provides that the Municipal Mayor shall allocate and assign office space to municipal and other officials and employees who, by law or ordinance, are entitled to such office space in the Municipal Hall and other building owned or leased by the Municipal Government;

WHEREAS, Section 447 (a)(4) of the Local Government Code provides that the Sangguniang Bayan shall regulate the activities relative to the use of land, buildings and structures within the municipality in order to promote the general welfare;

WHEREAS, the Revised Market Code of Taytay, Rizal recognized the need to regulate the use of stalls, booths or other structures inside the Public Market and its premises;

WHEREAS, because of the developments and other expansion of governmental and private activities in our municipality, there are government offices whose functions have expanded as their personnel increased so that they should be provided with their own office space;

WHEREAS, currently, there are already government offices located at the third floor of the New Taytay Public Market;

WHEREAS, there are still vacant spaces in the said floor which can also be converted as Government Offices;

WHEREAS, providing or relocating government offices in the New Taytay Public Market will not only decongest the present offices, cut or avoid rental expenses, provide comfort to those who visit the said offices and is in consonance with promotion of the general welfare;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE LOCAL CHIEF EXECUTIVE, MAYOR ALLAN MARTINE S. DE LEON TO TEMPORARILY ALLOCATE THE THIRD FLOOR OF THE NEW TAYTAY PUBLIC MARKET FOR GOVERNMENT OFFICES.

RESOLVED FURTHER, that appropriate construction or renovations that are necessary to be made to the present stalls located in the third floor be authorized so that they may properly be converted to government offices without significantly altering their original purpose as part of the New Taytay Public Market.

RESOLVED FURTHERMORE, that the accessibility and security of the third floor of the New Taytay Public Market be studied and considered in order to make the said floor open and accessible to the public.

RESOLVED FINALLY, that this Resolution be furnished to all offices concerned.


