RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON.
ALLAN MARTINE S. DE LEON, TO ENTER INTO AND SIGN A
MEMORANDUM OF AGREEMENT (MOA) AND/OR MEMORANDUM OF
UNDERSTANDING (MOU) IN BEHALF OF THE MUNICIPALITY OF
TAYTAY, RIZAL FOR THE IMPLEMENTATION OF PROJECTS,
PROGRAMS AND ACTIVITIES (PPAs) FROM VARIOUS NATIONAL
GOVERNMENT DEPARTMENTS, OFFICES, AGENCIES, POLITICAL
SUBDIVISIONS AND GOVERNMENT FUNDING ENTITIES TO THE
MUNICIPALITY

WHEREAS, the National Government Departments, Offices, Agencies, Political Subdivisions and Government Funding Entities from time to time tap Local Government Units to implement their Projects, Programs and Activities (PPAs) to reach the grassroots level;

WHEREAS, before the implementation of these PPAs a Memorandum of Agreement (MOA) and/or a Memorandum of Understanding (MOU) is needed to be executed between the National Government and the Local Government Unit;

WHEREAS, there is a need to consolidate / synchronize the action of all stakeholders to avoid delay in the implementation of a vital projects, such as livelihood, flood control program and other programs and activities that would reduce poverty incidence in all identified areas of this Municipality;

WHEREAS, the Hon. Allan Martine S. De Leon, Municipal Mayor, has to be authorized first by the Sangguniang Bayan before entering into any MOA and/or MOU for this purpose;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE, HON. ALLAN MARTINE S. DE LEON, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) AND/OR MEMORANDUM OF UNDERSTANDING (MOU) IN BEHALF OF THE MUNICIPALITY OF TAYTAY, RIZAL FOR THE IMPLEMENTATION OF PROJECTS, PROGRAMS AND ACTIVITIES (PPAS) FROM VARIOUS NATIONAL GOVERNMENT DEPARTMENTS, OFFICES, AGENCIES, POLITICAL SUBDIVISIONS AND GOVERNMENT FUNDING ENTITIES TO THE MUNICIPALITY.

RESOLVED FURTHER, that the 12th Sangguniang Bayan shall be directly informed in writing beforehand of the PPAs to be funded by National Government Department, Offices, Agencies, Political Subdivisions and Government Funding Entities before the implementation.

RESOLVED FURTHERMORE, that the said MOA and/or MOU shall be ratified first by the 12th Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMOST, that the 12th Sangguniang Bayan shall be furnished with copy of the duly signed MOA and/or MOU executed between the Implementing Agency and the Municipality of Taytay.

RESOLVED FINALLY, that a copy of this Resolution be forwarded to the Hon. Allan Martine S. De Leon for his information and appropriate executive action.
