A RESOLUTION APPROVING IN REVIEW THE BARANGAY EXECUTIVE ORDER NO. 1 AND BARANGAY EXECUTIVE ORDER NO. 3 OF BARANGAY DOLORES BOTH ISSUED ON THE 20TH OF JULY 2022

WHEREAS, Section 447 (a)(1)(i) of the Local Government states that the Sangguniang Bayan shall “review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punong Barangay”;

WHEREAS, the aforementioned statute has undergone the review of the Committee on Rules, Resolutions and Ordinances to check on the merits of the pronouncement from the Barangay’s Local Government Unit;

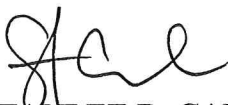
WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said declaration as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions and Ordinances;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW THE BARANGAY EXECUTIVE ORDER NO. 1 AND BARANGAY EXECUTIVE ORDER NO. 3 OF BARANGAY DOLORES BOTH ISSUED ON THE 20TH OF JULY 2022.

RESOLVED FURTHER, that copies of this Resolution and the approved Committee Report No. 2 of the Committee on Rules, Resolutions, and Ordinances be furnished to the Sangguniang Barangay concerned for their information and appropriate action.
