WHEREAS, with the constant growth in the enrollment of pupils in public schools and the inevitable scenarios of classrooms being used from time to time as evacuation centers, it is but fitting to add and improve the number of classrooms in our school campuses;

WHEREAS, San Isidro Elementary School has its oldest school building due for replacement of a new one, as the old two-storey school building constructed in 1994 is now dilapidated and appears to be the only classrooms still with wood floorings making it susceptible to further damages as the location of the school is generally flood prone;

WHEREAS, the Local Government Unit of Taytay has insufficient funds for the construction of the said school building thus entails seeking the support of the Provincial Government in responding to the clamor and request of the teachers and parents of the pupils of San Isidro Elementary School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby HUMBLY REQUESTS THE HONORABLE GOVERNOR NINA RICCI YNARES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A FOUR-STOREY SIXTEEN CLASSROOM YNARES TYPE BUILDING AT SAN ISIDRO ELEMENTARY SCHOOL.

RESOLVED FURTHER, that the school's site plan and photos of the damages within the building form part as attachment of this Resolution and, that copies of this Resolution be furnished to all concerned for their kind consideration and perusal.
