WHEREAS, during the emergence of different community quarantine levels and the uncertain period of the COVID-19 Pandemic, the Hiway 2000 Campus of Benjamin B. Esguerra Memorial National High School was converted into a quarantine dormitory for patients who have been tested positive for COVID-19 and have been required to be isolated;

WHEREAS, after more than a year of being utilized as a quarantine facility for the whole Municipality, the campus was returned to the stewardship of the school administration, however, some of the classrooms, restrooms and equipment have been damaged and are in need of refurbishing and repair to be adequate for the use of incoming students and school personnel;

WHEREAS, in preparation for the 100% in-person classes for the School Year 2022 – 2023 it is necessary to have the necessary improvement and renovation of the school campus fitting for the first ISO Certified Public School in Rizal;

WHEREAS, the Local Government Unit of Taytay has insufficient funds for the renovation of the said school campus thus entails seeking the support of the Provincial Government in responding to the clamor and request of the teachers, parents and students of Benjamin B. Esguerra Memorial National High School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby HUMBLY REQUESTS THE HONORABLE GOVERNOR NINA RICCI YNARES TO ALLOCATE FUNDS FOR THE NECESSARY IMPROVEMENTS AND RENOVATION OF BENJAMIN B. ESGUERRA MEMORIAL NATIONAL HIGH SCHOOL HIGHWAY 2000 CAMPUS, BRGY. STA. ANA,

TAYTAY, RIZAL THAT SERVED AS THE ISOLATION FACILITY OF THE MUNICIPALITY OF TAYTAY DURING THE PEAK OF THE COVID-19 PANDEMIC.


