WHEREAS, Chapter II, Section 17 (3)(v) of Republic Act No. 7160, otherwise known as the Local Government Code, states the Provincial Government shall provide Basic Services and Facilities which includes “[s]ocial welfare services which include programs and projects on rebel returnees and evacuees; relief operations; and population development services”;

WHEREAS, the Office of Purok 5, located at Block 25 corner Ynares Avenue Lupang Arenda, Barangay Sta. Ana, Municipality of Taytay, Province of Rizal, currently suffers from extreme flooding and mud build-up due to the dilapidated condition of the structure, and abrupt increment of the general elevation of roads from repairs and reconstructions;

WHEREAS, the Office of Purok 5, Lupang Arenda, Barangay Sta. Ana, Municipality of Taytay, Province of Rizal, has been in such battered condition for a long time already;

WHEREAS, the repair and reconstruction of the Office of Purok 5, Lupang Arenda, Barangay Sta. Ana, Municipality of Taytay, Province of Rizal, is not included in the budget of the Municipal Government;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby RESPECTFULLY REQUESTS THE RIZAL PROVINCIAL GOVERNOR, HONORABLE NINA RICCI A. YNARES-CHIONGBIAN, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A MULTI-PURPOSE HALL AT PUROK 5, LUPANG ARENDA, BARANGAY STA. ANA, MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of the Governor of Rizal and all concerned for their consideration and perusal.


