NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby REQUESTS SENATOR JUAN EDGARDO "SONNY" ANGARA AND SENATOR CHRISTOPHER LAWRENCE "BONG" GO FOR FUNDING FOR THE COMPLETION OF THE CONSTRUCTION (PHASE 5) OF THE TAYTAY SPORTS COMPLEX.
