WHEREAS, Section 16 of R.A 7160 provides that “Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.”;

WHEREAS, section 444 (b) (1) (vi) of R.A 7160 further provides that “Upon authorization of the Sangguniang Bayan, represent the municipality in all of its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinances. ”;

WHEREAS, DOH Department Circular 2021-0539, otherwise known as the “Interim guidelines for the implementation of vaccination activities during the Bayanihan, Bakunahan National" Vaccination Days 1 and 2 (NVD) dated November 29 to December 1, 2021 and December 15 to 23 respectively, which was launched as a strategy for National COVID-19 vaccine deployment and vaccination program, mobilizing all stakeholders, personnel and logistics to facilitate the vaccination in the spirit of Bayanihan;

WHEREAS, in the NVD 1 and NVD 2, CALABARZON ranked first in the COVID-19 vaccination with the highest total numbers of jabs administered nationwide;

WHEREAS, in recognition of the support of Local Government Units, health care workers, volunteers and other partners in the successful NVD implementation, CHD - CALABARZON has resolved to grant incentives to those with outstanding Bayanihan, Bakunahan achievement;


WHEREAS, this Resolution is being passed for the purpose of authorizing the Local Chief Executive to enter into a Memorandum of Agreement with the Department of Health with respect to the grant of incentive for the locality with the highest total number of jobs administered nationwide;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, duly assembled in session, to hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE, HON. ALLAN MARTINE S. DE LEON, MAYOR, TAYTAY, RIZAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPALITY, WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT – CALABARZON, REPRESENTED BY DR. ARIEL I. VALENCIA, MD, MPH, CESO III, DIRECTOR IV – CHD CALABARZON, WITH RESPECT TO THE GRANT OF INCENTIVE FOR THE OUTSTANDING BAYANIHAN, BAKUNAHAN ACHIEVEMENT (NATIONAL VACCINATION DAY 1 AND 2).
