WHEREAS, Title II, Chapter III, Article I, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Title II, Chapter III, Article I, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, through the Municipal Health Office, the University of the East Ramon Magsaysay Memorial Medical Center communicated its intent to conduct several medical programs of voluntary nature within the Municipality of Taytay, Province of Rizal;

WHEREAS, the voluntary service being offered by the University of the East Ramon Magsaysay Memorial Medical Center will definitely benefit the Taytayeno constituents of the Municipal Government;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL IN THE MEMORANDUM OF AGREEMENT FOR THE ROTATION OF THE STUDENTS OF THE UNIVERSITY OF THE

EAST RAMON MAGSAYSAY MEMORIAL MEDICAL CENTER WITHIN THE MUNICIPALITY, AND FOR OTHER PURPOSES.
