WHEREAS, Barangay Micro Business Enterprises (BMBEs) is a business entity engaged in the production, processing and manufacturing of products and commodities, including agro-processing, trading and services, whose total assets includes those arising from loan but exclusive of the land on which the particular business entity’s office, plant and equipment are situated shall not be more than 3 Million Pesos;

WHEREAS, the aim of this act is to integrate micro enterprise in the informal sector in the mainstream of the economy, as well as to generate a much needed employment and to alleviate poverty;

WHEREAS, the purpose of this law is to acknowledge every micro business enterprises in the Municipality and encourage them to register in the Treasury Office of the Municipal Government of Taytay, Rizal and issue a Certificate of Authority from the said office for them to avail the benefits and incentives declared under this Act;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby ADOPTS REPUBLIC ACT NO. 9178 ENTITLED “AN ACT TO PROMOTE THE ESTABLISHMENT OF BARANGAY MICRO BUSINESS ENTERPRISES (BMBEs) PROVIDING INCENTIVES AND BENEFITS THEREFORE AND FOR OTHER PURPOSES.
