WHEREAS, this Magna Carta also promotes the linkages between large and small enterprises, to establish common service facilities and make the private sector a partner in the task of building up MSMEs through the promotion and participation of private voluntary organizations, viable industry association and cooperatives;

WHEREAS, in coordination with the local government units, the State shall accelerate the decentralization process by establishing regional and provincial offices in order to enhance and attain greater efficiency in the provision of services to the countryside and implementation of this Act;

WHEREAS, the important mandate provided by this law, is that it directed all lending institutions to set aside a certain portion of their credit portfolios for SMEs and to laid out certain parameters and measures to achieve its objective;


WHEREAS, to carry out the objective of this law is to create a Small and Medium Enterprise Development Council through an Executive Order by the Local Chief Executive in every Local Government Unit;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby REQUESTS OUR LOCAL CHIEF EXECUTIVE HON. 
