WHEREAS, Title II, Chapter III, Article I, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinances;

WHEREAS, Title II, Chapter III, Article I, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Title II, Chapter III, Article I, Section 444(5) of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, the donor, Delia N. Suarez is the registered owner of the road lots identified as Road Lot 1 (520 sqms), Road Lot 2 (472 sqms), Road Lot 3 (108 sqms), Road Lot 4 (211 sqms), Road Lot 5 (618 sqms), Road Lot 6 (144 sqms), Road Lot 7 (112 sqms), Road Lot 8 (94 sqms), Road Lot 9 (88 sqms), and Road Lot 10 (142 sqms);


WHEREAS, the donor, Delia N. Suarez hereby transfers the conveys by way of Donation, unto the said Donee the above-described road lots with all its rights, interests and titles, free from all liens and encumbrances;
