WHEREAS, Section 5, Article X of the 1987 Constitution provides that Local Governments have the power to "create its own sources of revenues and to levy taxes, fees, and charges subject to such guidelines and limitations as the Congress may provide, consistent with the basic policy of local autonomy";

WHEREAS, Section 16 of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code states that, "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, entering into agreements with digital payment services will strengthen the mission of this Municipality to preserve the comfort and convenience of all its inhabitants through the use of technological tools available in the market nowadays;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE AND SIGN CONTRACTS WITH VARIOUS E-WALLET SERVICE PROVIDER FOR THE MUNICIPAL GOVERNMENT'S E-PAYMENT SERVICES, AND FOR OTHER PURPOSES.
