**A RESOLUTION GRANTING THE AUTHORITY TO THE LOCAL CHIEF
EXECUTIVE, HON. GEORGE RICARDO R. GACULA II, TO NEGOTIATE
AND ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH ABM
LABORATORY AND DRUG TEST FOR THE SCREENING AND TESTING OF
DRUG SURRENDEREES AND THOSE UNDERGOING PLEA BARGAINING,
UNDER THE COMMUNITY BASED DRUG REHABILITATION PROGRAM
(CBDRP) OF MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC),
TAYTAY, RIZAL**

WHEREAS, existing Board Regulation of the Dangerous Drug Board (DDB) mandated the Local Government Units (LGU's) through its Municipal Anti-Drug Abuse Council (MADAC) to facilitate and rehabilitation services and intervention to drug surrenderers;

WHEREAS, the Municipal Anti-Drug Abuse Council (MADAC) of Taytay, Rizal, under its Community Based Drug Rehabilitation Program (CBDRP) has on its register a total of 301 drug surrenderees who as part of interevent is processes need to undergo screening and testing for drugs;

WHEREAS, ABM Laboratory and Drug Test, a Department of Health (DOH) accredited screening and drug testing center, located at 1st Floor ARC Place Building #2 Sumulong Street, Barangay Dolores, Taytay, Rizal has offered its services to perform drug testing screening for the drug surrenderees and those being processed for plea bargaining under the CBDRP of the MADAC of Taytay, Rizal;

WHEREAS, to fully attain the avowed objectives of Municipal Anti-Drug Abuse Council (MADAC) transforming those surrenderees into productive and useful members of their respective communities, support must be accorded by the Sangguniang Bayan in implementing the program being pursued by the MADAC, Taytay, Rizal;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby GRANTS THE AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON.
