## RESOLUTION NO. 416 series of 2022

### RESOLUTION RETURNING APPROPRIATION ORDINANCE NO. 1 SERIES OF 2021 OF BARANGAY DOLORES, TAYTAY, RIZAL

WHEREAS, on November 29, 2021, Barangay Dolores, through its Punong Barangay Allan Martine S. De Leon submitted to the Sangguniang Bayan Appropriation Ordinance No. 1 Series of 2021 adopted on November 10, 2021, providing for the annual budget of the said barangay for review as mandated by the Local Government Code;

WHEREAS, the Sangguniang Bayan have the power to review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and the Punong Barangay as stated in the Local Government Code;

WHEREAS, Section 57 Review of Barangay Ordinances by the Sangguniang Panlungsod or Sangguniang Bayan states that: (a) Within ten (10) days after its enactment, the Sangguniang Barangay shall furnish copies of all Barangay ordinances to the Sangguniang Panlungsod or Sangguniang Bayan concerned for review as to whether the ordinance is consistent with law and city or municipal ordinances;

WHEREAS, Section 333 Review of Barangay Budget of RA No. 7160 states that: (a) Within ten (10) days from its approval, copies of the Barangay ordinance authorizing the annual



appropriations shall be furnished the Sangguniang Panlungsod or the Sangguniang Bayan, as the case may be, through the city or municipal budget officer;

WHEREAS, the Appropriation Ordinance No. 1 Series of 2021 of Barangay Dolores was submitted to the Sangguniang Bayan beyond the prescribed period stated in the Local Government Code;

WHEREAS, on January 14, 2022, Barangay Councilor Diego B. Samson, together with Barangay Councilors Rufe C. Tapawan, Jose P. Torio Jr., Estregan P. Cayton and Carl John R. Torres, and SK Chairperson Zyrell May B. Villanueva wrote a letter to the Sangguniang Bayan stating that the Appropriation Ordinance No. 1 Series of 2021 and Ordinance No. 2 were submitted without the approved minutes being duly signed by the members of the Sangguniang Barangay and that there were no official sessions conducted to properly discuss and deliberate the said ordinance and that the member who moved for the approval of the ordinances did not make any motion for their approval;

WHEREAS, majority of the members of the Sangguniang Barangay in their letter dated January 14, 2022 further raised the legality of the adoption of the Appropriation Ordinance No. 1 Series of 2021 and Ordinance No. 2, their adoption being inconsistent with law and this should also be rectified;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RETURNS APPROPRIATION ORDINANCE NO. 1 SERIES OF 2021 OF BARANGAY DOLORES, TAYTAY, RIZAL.


RESOLVED FURTHER, that Appropriation Ordinance No. 1 Series of 2021 of Barangay Dolores, Taytay, Rizal be declared INOPERATIVE IN ITS ENTIRETY until such time, that the Barangay concerned resolved all their issues internally and the Barangay Treasurer of Dolores, Taytay, Rizal shall not make further disbursement from any item of appropriation of the said Ordinance.

RESOLVED FURTHERMORE, that the Sangguniang Bayan recommends that; being internal in character. The issues or concern of the Barangay Officials of Barangay Dolores shall be resolved in the Barangay.


