**A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE RIZAL
PROVINCIAL GOVERNOR REBECCA A. YNARES TO ALLOCATE FUNDS
FOR THE CONSTRUCTION OF A MULTIPURPOSE HALL AT
SUMMERFIELD VILLAS, BARANGAY SAN JUAN, TAYTAY, RIZAL**

WHEREAS, Section 17 of the Local Government Code states that the construction of infrastructure facilities that are geared towards the delivery of basic services are part of the general powers and attributes of the Local Government Units;

WHEREAS, to provide a conducive space for general use of the homeowners of Summerfield Villas, a multipurpose hall is necessary which can serve as a venue for the programs and activities within their community;

WHEREAS, in December of 2018, the 10th Sangguniang Bayan of Taytay authorized the Local Chief Executive, Honorable George Ricardo R. Gacula II to accept the deed of donation of all road lots and alleys of Summerfield Villas thru Resolution No. 366 series of 2018;

WHEREAS, on February 8, 2022, the 11th Sangguniang Bayan of Taytay adopted Resolution No. 417 series of 2022, ratifying the deed of donation of Summerfield Homeowners Association Incorporated to the Local Government of Taytay executed on January 27, 2022;


WHEREAS, the purpose of the said donation of alleys and road lots is for improvement purposes and the acceptance is to pave the way for a possible construction of establishments using government funds within the pool area of the aforementioned subdivision;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RESPECTFULLY REQUESTS THE HONORABLE RIZAL PROVINCIAL GOVERNOR REBECCA A. YNARES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A MULTIPURPOSE HALL AT SUMMERFIELD VILLAS, BARANGAY SAN JUAN, TAYTAY, RIZAL.

RESOLVED FURTHER, that copies of the Deed of Donation, Site Development Plan and Sangguniang Bayan Ratification form part of this Resolution and be furnished to the Office of the Governor of Rizal and other offices concerned for their perusal.
